## Terms & Conditions of Skip Hire

The small print.

1. For the purposes of these conditions "Carrier" means Axe Skip Hire . "Customer/Producer" is the names hirer.
2. The hiring of the bin will commence on the date of delivery to the address shown on the attached invoice.
3. The hiring charge will continue to be chargeable until the Customer/Producer has complied with all terms of the hire.
4. Payment shall be due on hire of the skip & will not be collected until payment has been received. Late payment will be charged at 2% above National Westminster Bank base rate.
5. The Customer/Producer warrants to the carrier that the information given at the time of hire is complete & accurate & the Customer/Producer hereby indemnifies the Carrier against all costs, claims, demands & liabilities in respect of any information which is or proves to be inaccurate & further indemnifies the Carrier against all fines, penalties & liabilities imposed on the Carrier or arising in respect of a non-compliance or contravention of any law or regulation relating to the container together with the costs or expenses thereto incurred by the Carrier.
6. The bin shall be loaded so that:-
  - (a) Dust will not escape whilst loading or travelling.
  - (b) The contents will not fall on the highway at rest or in transit
  - (c) No inflammable, explosive, noxious ,or dangerous materials or anything which is or becomes a nuisance is loaded
7. The Customer/Producer must:-
  - (a) Not board up the bin
  - (b) Not light fires in the bin
  - (c) Not overload the bin
  - (d) Not remove or interfere with any identification mark on the bin
  - (e) Notify the Carrier as soon as possible when the bin is full
  - (f) Not re-site the bin
  - (g) Immediately notify the Carrier of any accident or damage involving the bin
8. The Customer/Producer shall be solely responsible for & hold the Carrier fully indemnified against all claims, demands, liabilities, losses, damages, proceedings, costs, and expenses which may be brought against or incurred by the Carrier as a result of any accident involving the bin(other than death or personal injury resulting from the negligence of the Carrier, his employees or agents).
9. The Carrier warrants that where the bin is to be positioned on private property all such permissions as are necessary for access to the site and the depositing of the bin at that site have been obtained and will continue at all times throughout the hiring.
10. If the skip is situated off the public highway but is likely to be a cause or contributory cause of damage or injury to any person during the hours of darkness than the Customer/Producer shall provide adequate warning light on the bin and the Customer/Producer shall also guarantee the safe loading of waste in the bin.
11. Damage to bins will charged at cost of repair.
12. Missing or stolen bins shall be charged at cost of replacement.
13. The bin should not contain tyres, liquid chemicals, inflammables, explosive, noxious or dangerous materials or anything which becomes a nuisance when loaded.
14. The Customer/Producer shall be solely responsible for any damage when siting the container e.g. Damage to surfaces, drain covers, kerb stones and when placing the bin over a wall.
